**1. Objectives**

- Provides easy access for you to buy and sell stocks on the floor of the NSE.
- Provide you with confidence through transparency in trading on your account.

**2. Features**

- Open a stock trading account (for new clients only)
- Completion of our KYC account procedures (for new clients only)
- You are required to fund your stock trading account to enable you trade.

**3. Benefits**

- Ability to trade in various classes of assets, including equities and fixed income securities.
- Direct interface with the NSE using our FIX-enabled online platform, you can trade at your convenience without the help of any broker.
- Ability to place orders online through any device.
- Ability to stay active and connected to the market anywhere you are.
- Prompt feedback on the status of mandates or orders.
- It allows you to determine your financial future.
- It allows you to take quick and timely investment decisions on your account.
- To increase your chances of maximizing returns on investment on your account.

**4. MODE OF OPERATION**

- i. Completion of ITI Trade application form.
